Tenders in sealed covers are invited for carrying out the above mentioned work , subject to the terms and conditions mentioned below:

1. The tender form with condition will be sold at the office of the Cantonment Board , St.Thomas mount on payment of Rs.500/- in cash upto 1300 hrs on 13.07.2018, DD for equivalent amount may also enclosed if the tender form is downloaded from website.
2. An Earnest Money of Rs.2000/- shall be paid in cash at the office of the Cantonment Executive Officer and the receipt should be enclosed to the tender while submission. The D.D for Rs.2000/-in favour of CEO, St.Thomas mount, is also accepted.
3. Rate shall be quoted in the prescribed tender form only to be sealed and the cover super-scribed as tender for “HIRING OF JCB” and place the cover in the tender box kept in the 16.07.2018 upto 1500 hours.
4. The tenders will be opened in the presence of the tenderers who are present at 1530 hours on 16.07.2018.
5. The board has the right to accept or reject any tender without assigning any reason whatsoever.
6. Tenderer shall be the owner of the JCB. Otherwise, he should submit the lease agreement copy from the owner of the JCB.

7. It is the duty of the successful tenderer to make arrangement for taxes if any to any authority etc., and to follow the necessary laws.
8. The rate includes driver wages, taxes, POL, driver allowance (Betta), service tax etc., and no other payment shall be made by this office.
9. The validity of tender shall be minimum of 60 days from the date of receipt.
10. The successful tenderer should within 3 days from the date of receipt of intimation, furnish non-judicial stamp paper to the value of Rs. 100/- for execution of an agreement for due fulfillment of the work.
11. The successful tenderer will attend the work mentioned above whenever calling and submit the bill for payment. The CEO will make payment only after completion and satisfaction of the work done.
12. Preference will be given to the tenderer who have similar experience with any other similar organization.
13. The Chief Executive Officer or his representative will be at his liberty to inspect the work at the site at any time during its progress and it shall be the duty of the tenderer to abide by the instruction to e given during such instruction as to the quality of work.
